







There are cars parked all along the road sometimes over 100 - and they are never given tickets. Let market forces and private industry decide how to manage their assets. When demand exceeds supply, industries can increase their prices. This will moderate overcrowding. The government can manage parks, such as Iao's Needle, to limit entry during periods of peak overcrowding. One way to do this is a reservation system. During peak times, have potential reserve a parking place. Keep some parking spaces free for day-of-travel entry, and have others available for reservation. 15 min. after reservation time, return no-show spaces back to day-of-travel availability. Cultural assets can be managed by increasing volunteer programs. Let the schools get involved. Have student complete cultural research projects for credit. Girl scouts and religious groups also can get involved. - Lahaina and Kehei/Wailea tourist areas. STRs permits need to be lowered to limit the continual encroachment on resident housing. Maui has reached or will shortly reach the limit of residents and visitors for the island precious natural resources.
- Lahaina HIstoric Districts #1 and #2. We have been advocating for more enforcement of the Historic District Ordinance for decades with little improvement. The County needs to create a full time Historic District Officer, with an office in Lahaina at the Old Lahaina Courthouse, to educate the businesses and the community about the existing rules and enforce them. A current plan to implement paid parking on streets on Front Street and surrounding streets could fund this important position as well as fund other infrastructure improvements.

- Marine preserve areas need to be more limited. Access for residents needs to be priority with tourist coming in second. Molokini and Honolua Bay Marine preserves need recovery days or even weeks. My suggestion would be to rotate ahupua'a ocean areas making them off limits for biological recovery and sustainability. The highly trafficked areas would be rotated through on a monthly basis, but not the same month every year. Create 10 modified areas, this way annually they will not repeat months off.

Mountain areas need better water management from developers on the West Side. The streams are extremely important for both the land and the sea. Create educational programs about this interactions with streams such as Kohoma from the top of the mountain to the ocean, talk about the native species and explain how the brackish water creates and sustains life in the ocean.

Maui needs to increase infrastructure. All of our current attractions are overrun because everyone is jammed into a small space. World population is increasing and we need to adapt.

We need to get some of the 85% privately owned land back to increase attractions for residents and tourists alike, such as camping, parks, and recreational areas to spread out the tourism population.

It just looks like overtourism because we are trying to jam everyone into 10% of the island.

- the road to Hana comes to mind: There should be a finite number of private vehicles allowed on any given day, with a permitting process. (This would exclude residents). There should be only so many tour vans/buses permitted to go daily. this would require monitoring at both Huelo and Kaupo.

Wainapanapa State Park. Has anyone asked the residents on that road how they feel about the constant flow of traffic in and out on the small narrow road?? I've lived here 35 years and remember when it was a pristine, quiet area.....not anymore. Flow into the park needs to be managed at the entrance with some form of gate/monitor. If the parking lot is full, no entry would be allowed instead of the flow of traffic only to find no parking available once you reach the lot.

- The Road to Hana should be an automatic toll road for passing rental cars, all generated funds should go back to the county
- 1 This doesn't sound like a legal idea.
- To protect our marine life and coral, it would be beneficial to alternate availability at protected sites such as Honolua Bay and Molokini. For example, during the off season, close these sites to commercial activity one or two days each week.
- 1 Toll for tourist!
- Tourists should have to buy a pass to go to Hana. Scan your pass and the gate will open and you can enter. This will help pay for upkeep of the road and increase revenue to the state.

Tourists, not residents, should be restricted. Require permits to limit number of visitors, but do not require permits for residents. I have not been able to go to sunrise at Haleakala or camp at Wainapapa the past few years (as had been my custom for the previous decade or more) because I cannot compete with hordes of tourists to get a permit or reservation. Keep some space and accommodations for local residents only.

Severely restrict the numbers of tourists on busses coming through Iao Valley. Have them stop below at Kepaniwai County Park, redevelop the County Park where there are restrooms to take pressure off the upper valley. Rdevelop the cultural hales to educate about Maui's diverse population. Allow safe access to the stream at Kepaniwai to prevent people from trespassing above to get to stream. Limit number of rental cars especially on Hana Highway. Encourage visitors to book shuttle with tour by culturally knowledgeable guide. Limit Hana highway to MAui residents, let torurists take shuttles

Many mainland airports have instituted noise abatement laws that reduce the number of hours airplanes may take off or land using flight patterns that fly over residential communities. Mainland airports have also required steep ascents and descents into airports where they fly over residential communities. This is critical in order to keep residents in support of tourism. The new flight patterns over the 96708 zip code with loud plane noise flying over at 6am, throughout the day and even as late as 8pm need to be addressed and flight patterns changed to ensure ongoing residential support of tourism on Maui. We have a lot of ocean these planes could easily fly over without disturbing our ohana.
- 1 Flights over Haiku should be eliminated! Especially the 6am flights to BI
- Focus on shifting our economy from tourism-based, to a self sustainable/agricultural economy
- Torget about moving the road mauka in the area between Lahaina and Papalaua. This would be very expensive and impractical. It would be only a matter of time before the road would have to be moved again, and again, etc. Instead, build seawalls where the ocean is undermining the road. Then put large rocks on the makai side to prevent ocean water from splashing onto the road like it does now at Ukumehame. Recent legislation expressly permits government agencies an exception to the prohibition of constructing of new seawalls. The tax payers, both residents and visitors, have paid for that road. It is totally irresponsible for the county government to allow the road to deteriorate because of coastal erosion. We have no practical alternative to this road. The road between Honolua Bay and Kahakuloa is too slow and hazardous in some places to permit heavy use for either residents or visitors to West Maui. It is time for government officials start listening to the "silent" majority of residents and not the Sierra Club, which fails to consider the practical impacts of their idealistic recommendations.

As if the large corporate hotels were somehow sacred and the only ones capable to provide a Malama Maui experience, over a small operator.

Kind of Hypocritical when she represents many activity companies that intrude on our local community recreation areas pretty insensitively in the past, and most never adapted to developing their Hawaiian Cultural delivery of their product..

- The flight path over Maui is a big consideration. Many residents are in uproar about the noise level, air pollution and safety issues around aircraft flying over our communities. There is plenty of ocean to fly over without disrupting residents peace and quiet and sense of safety. At times, planes fly over our community when they could just as easily flown over the ocean. I know the airlines are concerned with time and fuel costs, but they are doing this at the expense of the residents of Maui
- The ocean needs help. Over fishing and not enough enforcement. The reefs need help as well. The abandoned cars could be cleaned up, sand blasted down to bare metal and could be tied together to create artificial reefs for divers and snorkelers alike. Similar structures have shown great success in other parts of the world. We could do sculptures and make it interesting all while creating new reefs for ocean wildlife. There needs to be moratoriums on fishing for certain species. Lobster and octopus to start, these are incredibly important species to the ecosystem and they are disappearing due to over harvesting. This applies to many other shell fish.
- The plan really needs to do more to address the issue of lodging. Visitors who stay in hotel rooms contribute more money to the local economy than those who stay in short term vacation rentals or condos. Consider that those in hotels will dine out more often. Those is vacation rentals and condos go to Costco (which is NOT a local business) and cook for themselves. Hotels employ more staff (cleaning staff, grounds staff etc.) than short term vacation rentals.

Short term vacation rentals have a large detrimental effect on the local economy. They take housing out of the long term rental pool contributing significantly to a housing shortage. They are often owned by non residents who see them as a business investment. That investment income leaves our state.

Your plan should not only include tighter enforcement on illegal rentals and higher taxes, but also a concerted move toward reducing the number of rentals. We should have maximum allowable numbers of short term rentals by census tract. We should make sure that any permits already granted are not necessarily renewed or carried over with a change of ownership.

I also see that you are discouraging the building of new hotels. I agree wholeheartedly BUT we should also discourage the building of new high end condos. Maui does not need more high end housing that does nothing to solve the affordable housing shortage while utilizing and adding to the strain on our resources. (and please no more "affordable" housing projects that are really all about big developers slipping their market priced developments in under the guise of affordable housing.) We should also enact laws that halt the creation of any

more timeshare properties. Timeshares and short term vacation rentals have both contributed mightily to the pre pandemic situation (that is, a decrease in the amount of money contributed to the local economy per tourist visitor). We need to maximize the contribution each tourist makes to our local economy while keeping the numbers manageable to decrease the pressure on our local resources, and the harm to our environment.

- 1 There seems to be no systematic analysis relating causes to impacts, or metrics that reflect the relationship of cause to impact. For instance the number of people here on a given day determines the amount of human waste and food waste, and pollution from motor vehicles. The waste and pollution are what degrade our air and water quality. Limit tourism such that the pollutant load that tourism brings does not exceed our ability to handle it, and make sure tourism industry pays its fair share of infrastructure costs. R-1 water is loaded with nutrients that is bad for the reef. IF you dont treat the waste more, and more people keep coming, the waste load of nutrients goes up. R-1 just tells you it is low in solids and has low microbial count, it tells you nothing about the waste load of nutrients and toxic compounds. IT is the wasteload that degrades water quality in the ocean.IF you use polluted R-1 water for irrigation, the pollution makes its way back to the ocean through groundwater and stormwater.. We need to limit the torurism such that is is within the carrying capacity of the isalnds resources. We have to have a systematic approach to doing that
- This plan should be a cooperative effort to economically diversify the return to tourism revenue.
- Time is now to redefine tourism as we need a paradigm shift because the past trajectory is not sustainable. HTA/HVCB/MVCB budgets need to be divested away from marketing efforts to sustainability; environmental, conservation, cultural, etc. If we lose the special character, sense of place, of Maui Nui then we have failed in our responsibility for our future generations. For example we can start by charging every visitor \$125 "environmental fee" for the privilege of coming to Maui and this funding can support the above along with infrastructure improvements. Education and communication are the key to effectively manage tourism and if done right I bet tourists would be very happy to pay this "environmental fee" as it becomes clear that we as a community value our aina/kai. The perception of the Maui brand would be elevated.
- toll to Hana on front and back side road for visitors- funds go to local land conservation efforts
 toll to travel between Honolua area and Mendes Ranch Wai he'e area- funds to go to land conservation efforts
 start raising money and completing studies to move the highway away from coast between na pali (grandmas surf spot) and Oluwalu area.

 plan a mixed use coastal experience with some areas left wild, and some with slight developments.
- Tourism in Maui needs to follow models from other islands like the Caribbeans or French Polynesia.

 Tourists do not rent cars and overcrowd the island. They stay in hotels that give them the entire experience. Hotels provide shuttles/tours to various places/activities around the island. Tourists are in tourist markets, villages, restaurants. They are spending money.

 Tourists in those islands are not overcrowding residence roads, stores, gas stations

(like Costco here). Rental cars are clearly marked with big orange stickers.

- Tourism needs to be kept in balance with other non tourism commercial activities, we should not be dumping all our commercial efforts into tourism, just take a good honest look at the effect on our community with sugar/pineapple went out, tourism took over, and the pandemic hit us. That never should have happened.
- 1 Water resources that get used by the hotels should also be limited if there are droughts. Don't expect just us residents to comply with those water advisories and not the tourists.
- We need to focus on quality visitors: people who respect the residents, the culture, the environment. These might actually be guests who stop for a plate lunch instead of going to Mama's Fish House or volunteer to restore native habitat instead of paying for an activity.

Encourage guests who want to know Maui, instead of Guests who want to be catered to on Maui.

- West Maui needs more roads, no new hotels nor housing until we can get out of this side of the island should an accident, fire or emergency occurs. or just in everyday life trying to get to the other side of the highway..
- When you say vans to improve ground transportation, I say it's good but what we need is an efficient public transportation system.

We should have fast buses staying on highways with fewer stops that connect with local door-to-door smaller buses or soon; self-driving vehicles.

The public transit should be extended and include the ferries to Molokai & Lanai and also extend routes to Haleakala and Hana.

Tourist would pay a week pass for the same price as a monthly kama'aina. The bus will need a marketing budget to promote it as the best way to move around the island.

Only when travel times will become similar to cars, frequency of service increased, with price cut in 4 compared to owning a car, proper marketing & design improvements to make it sexy, only then social acceptance will build and provide a sustainable means of transportation for Maui.

This can start by raising rental car taxes in order to finance its expansion, but my proposed plan starts by optimizing the performance of existing vehicles&drivers with better routes that can save up to 60% travel time as demonstrated in the fully redesigned schedules and network connections in my white paper.

I hold diplomas in marketing, public transportation, and hospitality management, and I would Love to participate, but up until now, no-one responds.

While I do not support requiring cultural activities, they could be very beneficial for all involved. Hawaii is a part of the United States. We get a lot more money from

the federal government than we contribute. If we want that special treatment, it comes with responsibilities. We should teach and speak English. However, schools should all offer optional language clubs. And probably a class in Hawaiian culture at some point. Too often culture gets quickly commercialized. I think the hula is amazing and is a tradition worth learning. But coconuts and grass skirts? Really? Surely, it can be better. Let's do real education for the locals and the tourists. If someone did something authentic, I believe people would pay.

1 Work toward non-tourism based economy. Provide non-tourism employment opportunities.

Tech: Make and Market Hawaii as the highest tech (universal highspeed internet to all households rural and urban) state in the union. Provide tech training at local community colleges for installation and maintenance of network. High tech immigration will provide tax resources.

Energy: set goal of fosil fuel independent in 10 years. Provide community college education for installation and maintenance of solar, wind, battery storage for our islands. Require all rental cars to be electric

Education: Make educator training, compensation and retention a priority for the state of Hawaii. Our Keiki should enter a system that is the equivalent of private education available to the few. Our graduates easily can be the envy of the Union.

You've mentioned illegal vacation rentals......the enforcement of laws/rules in place needs to be a priority, not just in that area, but across many sectors. Regulations are put in place, but little seems to be done to enforce regulations.....even the obvious ones.....like illegal vehicles on the road (jacked up trucks, wide tires, etc.) If those laws are not enforced how can we believe the less obvious ones, like the illegal rentals are even being considered. This is a huge problem, and one that I know will not be corrected over night and will take considerable manpower behind the scenes.

There should be a limit to the total number of private vacation rentals island wide, especially in some of our quieter neighborhoods that wish to remain that way.

I also sent a letter to Mayor Victorino's office about reshaping tourism, back on April 24th 2020, for which I got no response....:(
I think the suggestions I made are still very relevant in terms of marketing strategies for our destination.

"I also offered to the Maui Hotel and Lodging Association, (as we are members and following up closely) to organize a task-force to brainstorm "10 best ways to change the service offering to offer a safe stay in Maui Hotels & BnBs", and then do some serious needs-based marketing research with different segments of travelers to identify which of those 10 service offerings resonate more with the different types of travelers.

Your leadership would help move that process forward. I would be happy to be at service to help facilitate this process in an efficient manner.

Then once the market research is nailed down, we should reshape our Tourism Marketing with online micro-targeting campaigns at low cost and see what works best before we scale up, as funds are precious and shouldn't be wasted. We need to be ready to radically differentiate our destination in our target markets as soon as the lockdown stops, especially we need to focus on the new core needs of safety that travelers will have.

If we want to avoid our economy to take years to recover, we need to take action NOW for the tens of thousands of Mauians on unemployment, we need to be smarter than ever to be sure our tourism kicks back in as soon as possible! Just being the destination Maui isn't a good enough strategy anymore.

And again, all this depends on some serious needs-based targeting, especially now

that potential visitors are broke, we will have more competition from Mexico and cheaper destinations and we will need to focus on a new "Safe Luxury" branding.

The Lt. Gov. said that airlines will be willing to test people before boarding planes to Maui, so that's already a huge help. All that can also help make the citizen feel safe and stop being so aggressive against visitors.

Approval of so many rarely owner occupied huge mansions have forced our kama'aina away while driving the home prices to unreachable levels.

- This is long overdue. Before Covid, it was to the point that residents were crowded out from previously pristine natural areas over run with tourists. . Get rid of videos in hotels and books that encourage visitors to trespass and frequent dangerous areas.
- This measures appear to be anti-tourism. Guised in the mask of protecting Maui's resources. Educating visitors to help us protect and utilize our resources is a good thing. But cutting off the hand that feeds us is another. As it is now, STR's are seen as the bad guys, but the hotels are getting a pass. Most STR's are Mom & Pop operations. While the hotels are major corporations who appear to have major sway with local politicians. We need to look at the Hospitality Industry as a whole and not just one portion of it.

There needs to be a balance on our approach to tourism. How do we maximize our tourist dollars and provide the best environmental protection at the same time. For some reason our local politicians are binary in their approach. It seems like they only see all in or all out. They lack the ability to see that there is middle ground and we can have both, protect our resources/environment and have tourism flourish at the same time.

The short term rental property tax classification is the largest contributor to the County Affordable Housing Fund annually. Rather than trying to squeeze more money out of individual property owners, who are providing jobs for locals and are already struggling with the high cost of living on Maui, the County needs to focus their efforts on how they allocate these funds. The hotels, having a lower tax rate could certainly afford to pay more in property taxes. 1 Visitor industry: promote locally owned tourism. Educate local residents through local colleges to manage their own BB, STR, small hotels. Keep tax and direct revenue on island. Limit each island visitor capacity. 1 We in Hawaii never should have let Washington, DC start allowing low cost cane sugar (grown with near slavery level paid workers, our Hawaii workers were ILWU, and were paid a decent living wage) come into the western US and put our Hawaii sugar growers out of business. Yes, the big bosses in DC wanted to be buddies with the top level Mexicans, most of whom were connected to the profits from their sugar operations in one way or another, but to eliminate the balancing of import tariffs on Mexican sugar, and put our Hawaii growers out of business, should have been blatantly illegal. We should have a law that says a non-Hawaii resident can only purchase 1 house/property currently owned by a non-Hawaii resident. A Hawaii resident may purchase any available home/property. This way ALL new housing is for residents and not luxury communities for non-residents. New revenues can be raised by implementing a scratch off lottery. 


